

DAHUA SUPER MILLIONAIRE QUIZ CONTEST– 2023

Terms and conditions:

1. Introduction:

This Dahua Super Millionaire Quiz Contest (“**Contest**”) is being organized by Dahua Technology India Company Limited, a company incorporated under the Companies Act’ 2013 having its registered address at 9th Floor, Tower A, DLF Cyber Greens, DLF Cyber City, Phase III, Gurugram, Haryana (India), Pincode: 122002 (“**Dahua India**” or “Organizer” or “We” or “us”).
